#### **Describe the rationale for the proposed program change(s):**

We wish to change the foreign language requirement for the PhD in English. Formerly, we required all students to demonstrate an ability to read and work in two languages other than English or an advanced ability in one language. Students could fulfill this requirement either through coursework or through a translation exam. We would like to change both the requirement and the exam.

First, we propose the creation of an equivalent category for "the acquisition of a skill or body of knowledge important to the student's dissertation topic" that would enable students to either master a second language or demonstrate their mastery of a skill. The skills category could take several forms, such as relevant work experience, volunteer service, or coursework at the University of Delaware or elsewhere on topics such as paleography, statistical analysis, and print technology, as long as they are relevant to the student's particular dissertation topic. Because the skills requirement will vary depending upon the student's research specialization, the graduate committee must approve proposals for a skills requirement.

Second, we propose changing the foreign language exam from a translation exam to a reading comprehension exam. Inasmuch as English scholars use foreign languages these days, it is to read and comprehend primary and secondary sources, not for the purpose of language or aesthetic analysis; therefore a comprehension exam tests the relevant skill better than a translation one. Comprehension exams are becoming more widespread in the field. In the new comprehension exam, students will now be asked to read a passage of approximately 1,000 words and then answer 3-4 questions based on the reading. The answers may be given in English. Students still may satisfy the foreign language requirement through coursework.

#### **Program Requirements:**
