Arab 200, Arab 201 and 205 are focused around the four language skills and students will continue improving their oral and written abilities in the conversation and grammar courses. Students will develop excellent reading comprehension and listening skills. This will enable them to access major information and news websites in Arabic language such as Aljazeera.net and other sites where they can listen to the news online, news podcasts, read and understand stories and news updates in Arabic.

# 10. Develop an international perspective in order to live and work effectively in an increasingly global society:

Trough literary explorations of novels, essays and plays students will be familiarized with some of the social and cultural issues of the modern Middle East and the important concerns in the Arab world today such as: the place and role of women in the society, the impact and the prospects of the Arab Spring, the role of Arab youth ..etc. Students will also be exposed to the ways Arab writers and intellectuals deal with the major backlashes, hopes and frustrations of the Arab society today such as the lack of freedom and resources, the emergence of extremism and wars. All these issues will be discussed through literary media.
