No new courses will be required for the revised curriculum. However, one new course will be an option to meet requirements in the curriculum. WOMS408/HDFS408: Domestic Violence Policy and Prevention will be an option to meet the risk elective. Please see below for justification.

The addition of classes as options to meet the current requirements will enhance students' ability to think critically and solve problems (Goal #2) in a wider variety of topic areas. These classes will also help students to attain skills in oral and written communication and the use of information technology (Goal #1). Requiring all students to take HDFS 470: Families and Children at Risk will also enhance students' abilities to work and learn both independently and collaboratively (Goal #4) since the course requires both individual and group work, and emphasizes the interdependent nature of different community services and policies.

HDFS 408: Domestic Violence Policy and Prevention is cross-listed with WOMS 408. Permission to add this course as one of the options for the "Individuals and Families at Risk" elective from Jessica Schiffman, Associate Chair of Women's Studies, is attached.

Describe the rationale for the proposed program change(s):

(Explain your reasons for creating, revising, or deleting the curriculum or program.)

1. The addition of HDFS 472: Substance Abuse and the Family and HDFS/WOMS 408: Domestic Violence Policy and Practice as options for meeting the Individuals and Families at Risk elective will broaden the available options for students interested in these issues. In addition, given the rates of both substance abuse and of violence in families, these two courses will each provide students with important information in providing services and community education programs across a variety of fields.

2. The addition of HDFS 403: Adult Disability Issues and HDFS 410: The Hospitalized Child as options for the Individuals and Families at Risk elective will align the Community Education concentration more closely with the other concentrations which already This change corrects an oversight in the creation of the Community Education concentration last year.

3. HDFS 470: Families and Children at Risk will be dropped as an option for the Individuals and Families at Risk elective and instead will be *required* for all students in the concentration. This class covers a broad range of topics and issues critical to providing appropriate services in the community for children and their families. Requiring this course within this concentration will also increase the consistency in requirements across the concentrations and majors within the department.

4. Currently, the concentration requires two specialty Human Development electives. Dropping one of the electives will allow students room to take the required HDFS 470 instead. Human development topics and issues are also covered across the other requirements, in courses such as HDFS 235: Survey in Child and Family Services and in EDUC 230: Introduction to Exceptional Children, and in the restricted electives.
