Describe the rationale for the proposed program change(s):

On January 1, 2011, the School of Urban Affairs and Public Policy became the School of Public Policy and Administration and moved to the College of Arts and Sciences. There are two reasons for the proposed revisions of the B.S. Degree in Organizational and Community Leadership.

1. **The BS in Organizational and Community Leadership needs to be revised to meet the requirements for the BS degree within the College of Arts and Sciences. These include increasing the number of credits for the BS degree from 120 to 124, increasing the range of credits for the First Year Experience from 0-3 to 0-4, changing the wording for the level of the Math requirement, adding a stronger foreign language requirement, and adding the College of Arts and Science's breadth requirements which includes a 4 credit lab science – which will replace our current 3 credit Physical and/or Biological Science requirement.**
2. **The Organizational and Community Leadership major courses requirements are being revised to provide more flexibility in course options.**
 - **The 3 credit Political Science requirement is being eliminated and those credits are now in the A&S Breadth Requirements.**
 - **The MATH 202 requirement is being broadened to include an opportunity to take other statistical and research methods courses as approved by the student’s advisor.**
 - **The options to complete the requirements for both LEAD 400 and LEAD 411 have been broadened to include courses within the School of Public Policy and Administration, or other courses approved by the student’s advisor.**
 - **These revisions also eliminate the current four areas of interest and allow students more flexibility to define their area in conjunction with their faculty advisor. Students will still have the opportunity to pursue a minor.**

A grade of C- is required in all major courses. No more than 45 credits with the same departmental prefix (including cross-listed courses) may be counted toward the total required for the degree.
