Describe the rationale for the proposed program change(s):

- Curriculum was redesigned to place full-time clinical internships at the end of the didactic curriculum. This follows the recommendations set forth from the American Physical Therapy Association.
- The Commission on Accreditation of Physical Therapy Programs requires 30 full-time weeks of clinical experience. That, along with requests from our clinical partners to have longer clinical internships, supports the change in number of weeks of each externship.
- Change to letter grading for all clinical experiences (full-time and integrated) provides greater standardization for evaluating student clinical performance and allows for greater differentiation amongst students.
- Change in name from Clinical Internship to Full-time Clinical Experience follows the recommendations set forth from the Academic Council for Physical Therapist Education.
