We propose changing the name of the Health Studies major to *Health Sciences* for two reasons.

The first is that *health sciences*, as compared to *health studies*, more accurately describes the existing science-based pre-occupational therapy concentration within the major.

The second reason is that the Health Studies major is not housed in a department, but is administered by the College. It is designed as an interdisciplinary major, drawing courses from four different academic units within the College. Since the name of our College is Health Sciences, it follows that our interdisciplinary major should also be named *Health Sciences*.
